

“2015 Watch of Your Dreams” Raffle Rules

1. **ENTRY:** Contest is sponsored by the Sandlapper Chapter of the BMW Car Club of America (“Chapter”). To enter, fill out a 3x5 index card with your Name, Address, Phone number, email and BMW CCA member number for each entry. Mail the completed card(s) with a check for \$5.00 per entry to: BMW CCA Foundation – WOYD, 190 Manatee Court, Greer, SC 29651-6701 via first-class mail postmarked by January 8, 2015. All entries become the property of the Chapter and will not be returned. Incomplete entries are invalid. Neither the Chapter, nor the BMW CCA Foundation are responsible for mailed entries that are late, lost, illegible, misdirected, mutilated, incomplete or postage-due, or for telephone system, computer hardware, software or program malfunctions or other failure errors, delayed transmissions, network connections, or data loss whatsoever. The Chapter, at its sole discretion, reserves the right to disqualify any entrant it finds to be tampering with the entry process or to be acting in violation of the Contest rules. The Contest ends at Noon, Friday, January 15, 2015. To be eligible mail-in entries must be postmarked by January 8, 2015.

2. **ELIGIBILITY:** Contest is open to Sandlapper Chapter members, age 21 or older, in good standing at the time of the drawing. Officers of the Sandlapper Chapter of the BMW Car Club of America and members of their households are not eligible. Void where prohibited.

3. **PRIZE:** A 2015 BMW CCA Limited Edition Watch. The winner shall be responsible for all State, Federal and local taxes, any sales and use taxes, and any other related taxes, fees and charges. Acceptance of prize constitutes permission to the Chapter and its agencies to use winner’s name, voice and/or likeness for purposes of advertising and trade in any media, worldwide, without further payment or compensation, unless prohibited by law.

4. **WINNER SELECTION:** Winner will be selected by a live random drawing conducted by the Chapter on January 18, 2015 at the Upstate Sandlapper Chapter meeting, Quaker Steak & Lube, Chrome Drive, Greenville, SC, or designated alternate location. Decisions of judges are final on all matters relating to this Contest. Prize will be awarded and the winner notified via e-mail and/or postal mail, as well as posted on the Chapter web site at www.sandlapperbmw.org. Winner must execute any required affidavit of eligibility/release of liability/prize acceptance form and, where lawful, Publicity Release within seven days of attempted notification. Noncompliance within this time period may result in disqualification and an alternate may be selected. If prize notification is returned as undeliverable, prize will be forfeited and awarded to an alternate.

5. **PRIZE RESTRICTIONS:** Winner will be responsible for all applicable taxes on prize. Winner must accept prize within thirty (30) days of notice of availability or prize may be forfeited and awarded to an alternate. No prize transfer or substitution.
